#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

#### **Skin Contact:**

**Short Term Exposure:** Available data indicates that this product is a sever skin irritant. Corrosion will continue until product is removed or neutralised. Severity depends on concentration and duration of exposure.

Long Term Exposure: Repeated exposure may cause skin dryness or cracking.

#### **Eye Contact:**

**Short Term Exposure:** This product is a severe eye irritant. It will quickly cause severe pain, and corrosion of the eye and surrounding facial tissues. Unless exposure is immediately treated, permanent blindness and facial scarring will occur.

#### Section 6 – Accidental Release Measures
